APPLICATION / SALARY / LICENSURE INFORMATION:

- Individuals who wish to be considered for this position will complete an online BWP Applicant Data Form at: www.bwpassociates.com.
- An application file must include a letter of interest indicating reasons for interest in the position, a current resume, and three letters of reference. Candidates must send these materials electronically with the online Applicant Data Form. Official transcripts will be required from candidates who are invited to interview with the School Board.
- The successful candidate's salary will be regionally competitive. The final salary and benefits will be negotiated and determined based on proven experience, qualifications, and meeting School Board criteria.
- Applicants are required to hold or provide evidence of eligibility for the Virginia Division Superintendent License. Candidates are encouraged to obtain information about requirements for licensure from the Virginia Department of Education at www.doe.virginia.gov.
